

Release Notes for WinRecs Version 295.0.1

Release Date: April 11, 2018

This exe patch must be run on WinRecs installations that are on version 295.0.0 and includes:

- Fixes for issues found in Version 295.0.0 as outlined in the release notes
- 2018 Cancer Care changes
- -2018 Rehab tables and RPG tables (clients with RPG grouper should group the 2018 Q1 assessments)

Important:

All Sites should apply this patch.

After all Fiscal Releases and Service updates have been applied coders should check to ensure they can see grouper values in the visits. For Citrix clients this should be confirmed on all Citrix IP addresses.

WinRecs Version 295.0.1 contains a Fiscal Grouper Engine update to address a CMG issue that was found during vendor testing (see Release note ticket PR-1166). Clients should batch group all 2017 and 2018 DAD Visits that were coded on WinRecs version 295.0.0.

NB: When Batch Grouping Clients should refrain from putting a Y in the "Flag Changed Records for Correction" field in the Batch Grouper. There is a known issue that all Submitted visits for the period being grouped will get flagged as corrections when a value of Y is entered. The fix for this issue will be in Service Release 295.1.0 in May, 2018 (this issue affects both DAD and NACRS).

Some hard edits were missing the expand option (+) - this has been corrected.

PR-1162 Death Disposition Codes Not Updating CPI Death Indicator

The CPI Death Indicator/Date Patient Died fields will update with the new Death Discharge Disposition Codes.

PR-1182 Run Time Error 91 When Opening 2018 Visits

When opening 2018 visits Run Time Error 91 would occur. This issue has been corrected.

PR-1208 Slowness When Entering Blood Fields

Slowness was reported in the Blood Information Fields when moving from one field to another. This issue has been resolved.

AmCare (NACRS)

PR-1205 Incorrect NACRS Edit with Dx Code T810

The following incorrect edit was firing in NACRS when Diagnosis code T810 was used: If Problem Cluster value is recorded with Main Problem T812 then there must be an Other Problem Y60- with the same Problem Cluster value as T812.

The edit will now only fire if T812 is used.

CMG+CACS

PR-1166 CMG Grouper Issue

The Institution To and From types were not being assigned in the grouper engine. This has been corrected. NB: All clients should batch group their data once on version 295.0.1.

Inpatient (DAD)

PR-1146 Group/Field numbers in DAD CJRR form

Group/Field Numbers now show in the DAD CJRR Form

PR-1159 Incorrect Edit DAD CJRR Intervention Joint Identifier

An incorrect hard edit was in place that for each occurrence with a CJRR intervention code that the intervention joint identifier (Group/Field 11 22) was mandatory. This was incorrect as there can only be one intervention joint identifier occurrence with a value of 1 and one intervention joint identifier occurrence with a value of 2. The edit will only flag as mandatory based on this rule.

PR-1169 Manitoba: Retired Weight Showing as Mandatory On Stillbirth Visit

Retired Element 07 03 Weight in grams (CIHI) was generating a hard error as mandatory on stillbirth visits. This error has been removed.

PR-1170 Incorrect Edit on Frequency of Restraint

When entering any value other than C in the Frequency of Restraint field the following incorrect hard error would generate:

If the submitting Institution Type is 1 (Acute Inpatient Care) or 5 (Inpatient Mental Health) and the Main Patient Service or one of the Transfer Services is 64 or 65 and Frequency of Restraint Use is recorded, then it must be C, D, I, U, or N.

This has been corrected so any of the above look up values can be entered.

PR-1173 CJRR & 3M Codefinder

When 3M Codefinder was used to bring in the CJRR Intervention codes and the Intervention Joint Identifier was populated, a run time error was generated when trying to leave the Intervention Multiform. This has now been fixed.

PR-1182 Run Time Error 91 When Opening 2018 Visits

When opening 2018 visits Run Time Error 91 would occur. This issue has been corrected.

ED-1184 NRS 2018 Validation Tables

The NRS ICD10 and CCI 2018 pick lists and validation tables have been included.

ED-1185 NRS RPG 2018-2019

The NRS RPG 2018-2019 values have been included in this patch.

Same Day Surgery (SDS)

PR-1183 Run time Error 91 Creating DAD Day Surgery Visit

When creating a new record in Same Day Surgery, when the record loaded a Run Time Error 91 would occur and the user would be booted out of WinRecs. This has now been fixed.

Utilities - Batch Grouper

PR-1176 Batch Grouper For NACRS Unavailable

NACRS Institution Numbers were not available in the Batch Grouper module until a corresponding visit was loaded for the batch group period. This has been corrected.

PR-1181 DAD Day Surgery Institution Numbers Not Available In Batch Grouper

DAD Day Surgery Institution Numbers were not available in the Batch Grouper utility. This has been corrected.

Utilities - CIHI Submissions

PR-1158 Incorrect DAD Submission Batch Verify Errors

When DAD CJRR Institutions run a submission verify the following incorrect hard error generated on non-CJRR cases:

There must be 1 occurrence of intervention joint identifier.

This error has been removed.

PR-1174 No Separation File Incorrect Length

A No Separations file still had the 2017 File length - this had been changed to the 2018 File Length.

PR-1210 ED Opioid submissions

ED Opioid submissions will allow for the following revised 2018 Opioid Codes: T40.20, T40.21, T40.22, T40.23, T40.28, T40.40, T40.41, T40.48

Utilities - Purge/Undelete

PR-1175 Records Not Automatically Purging

Dad visits in the purge module were not automatically purging after a deletion file was created and would get picked up in each additional deletion file created. This has been resolved.
