

Release Notes for WinRecs Version 295.1.0

Release Date: May 17, 2018

This release must be run on WinRecs installations that are on version 295.0.0 and includes:

- Fixes for issues outlined in the release notes
- 2018 OMHRS Changes including OMHRS SCIPP Grouper Update

Important:

After all Fiscal Releases and Service updates have been applied coders should check to ensure they can see grouper values in the visits. For Citrix clients this should be confirmed on all Citrix IP addresses.

WinRecs Version 295.1.0 contains a Grouper Engine update to address a CMG issue that was found during vendor testing (see Release note ticket PR-1211) as well as 2018 SCIPP Grouper update. Clients should batch group related visits for these changes.

EN-0787 Abstract Queue

In Abstract Queue the search will be expanded to other fields such as Chart Number, Encounter/Registration Number, Discharge Nursing Area and Disposition Code. The first column will display the search field.

EN-1037 Folio Code Basket

The integration with Folio now allows selection of multiple diagnosis and interventions codes to import to WinRecs using the Folio Code basket. When Folio launches WinRecs shows a dialogue box that the Coder will use to indicate when the Folio session is complete (allowing WinRecs to pull the selected codes from the Code Basket). Once all codes have been added to the code basket clicking OK on the dialogue box will import the codes into WinRecs.

PR-1212 Batch Grouper-Flag Records as a Correction

When a "Y" was entered in the "Flag Changed Records for Corrections" all submitted records for the period being grouped were flagged as corrections. This issue has been resolved and only visits with grouper changes will be flagged as corrections.

AmCare (NACRS)

PR-1220 Expired Fields Disabled

Expired Information Fields did not enable when Death Visit Disposition is entered. Fields will now enable for internal collection only.

PR-1223 Incorrect Hard Edit - Diagnosis Prefix 8

The following incorrect hard edits were generating when Diagnosis Prefix 8 was used with Main or Other problem:

If Main Problem Prefix is coded, then it must be alphabetic

If Other Problem Prefix are coded, then the Other Problem Prefix must be alphabetic

This edit has been removed.

MDS20 Quality Indicator Views were returning the incorrect values for the following:

PRU06 — Percentage of residents whose stage 2 to 4 pressure ulcer worsened

PRU09 — Percentage of residents with a newly occurring stage 2 to 4 pressure ulcer

ED-1249 Manitoba: MH Facility To and From Defaults

If 61999, 62996, 69599, 69399, 69498, 69496, 69798, 69799, 69899, 69699 is entered in the Institution From field the MH Transfer Facility From field will auto-fill with 9999.

If 61999, 62996, 69599, 69399, 69498, 69496, 69798, 69799, 69899, 69699 is entered in the Institution To field the MH Transfer Facility To field will auto-fill with 9999.

PR-1235 DAD Run-time Error 3021

The following Run Time error was reported when trying to pull certain DAD Visits: Runtime Error: 3021: Either BOF or EOF is True or the current record has been deleted. Requested operation requires a current record.

This error occurred when the Cement and/or Component Areas in the DAD CJRR form had values but the Parts section was left blank. This issue has been corrected.

PR-1239 Manitoba - Hard Error Institution To

When Institution To field is populated and the MH Facility to field auto-populates a hard error generated stating the Institution to and the MH Facility to must be completed. The error was removed upon save or verify.

This error is now removed when the fields are populated no longer requiring a verify or save to remove the error.

PR-1225 Project 250 DAD - Unable to deactivate

When trying to change the valid from date for Project 250 DAD - getting an error saying the record cannot be saved because of a problem on the server. This has now been fixed and users are able to deactivate.

Utilities - Batch Grouper

PR-1211 CACS: Intervention Used

For completed Amcare Records that were batch grouped the CACS "Intervention Used" field in the CACS Calculation box showed intervention code 1.AA.13.HA-C2. This issue has been resolved and the correct value will now display if the intervention code contributes to the CACS calculation otherwise it will show blank.

NOTE: This did not affect database values or CACS report values only the value that displayed in the CACS Calculation box. This fix required a grouper update in this release.
