Release Date: September 27, 2018

This release must be run on WinRecs installations that are on minimal version 295.0.0.

Important:

A RPG Grouper methodology change has been included in this release (see ticket 1366). Sites that have the NRS RPG Grouper should regroup all data to apply the fix to the visits.

After all Fiscal Releases and Service updates have been applied coders should check to ensure they can see grouper values in the visits. For Citrix clients this should be confirmed on all Citrix IP

ED-1347 Manitoba Health Revised Edits August 2018

The following four Manitoba edits have been added to WinRecs for 2018 DAD records.

- 1. MH Facility To must be blank if field 0504 (Institution To) is blank
- 2. MH Facility From must be blank if field 0404 (Inst From) is blank.
- 3. Institution To must not start with 6027 or 6028*, 6029 , 6827 , 6828 or 6029 \
- 4. Institution From must not start with 6027 or 6028*, 6029 , 6827 , 6828 or 6029 \

For Alberta submission files, the filler length in the control record of the file has been corrected to the appropriate length.

A new field has been added to the intervention multiform for DAD and NACRS. This field name is "Intervention comments" and the field length is 1000 characters. This field is not submitted and can be used for internal collection.

EN-1387 SQL Warning Message

For suspected SQL issues the following error will now generate:

Cannot start WinRecs. Database may be out of disk space. Please have IT/Administrator verify.

PR-1302 Abstract Profile: Invalid Main Diagnosis

When a valid Diagnosis code was used in an Abstract Profile the following hard error generated: "Invalid Diagnosis Code for Main"

This error will no longer generate when the diagnosis code is valid.

PR-1354 Incorrect Edit Intervention Code 7SC08PM

When the Intervention code 7SC08PM was coded as an Other Intervention with the correct Diagnosis codes the following error would display:

"If problem is Z51.81 then Main/Other intervention 7SC08PM must be coded and there must be at least one Problem from A00-T98 with the Problem Prefix "J"

This has now been fixed and the code can be coded as an Other Intervention.

PR-1390 3M - MAID - Type of Delivery Attributes

The MAID intervention attribute 'DI' was not coming across from 3M Codefinder. This issue has been fixed.

A Triage Date Unknown field has been added to the I10 Projects 640 VR.

Inpatient (DAD)

ED-1364 Remove Two DAD Warnings

As per new CIHI Edit specs the following two DAD CJRR warnings have been removed: 11 22 50: If the first character of the institution number is Nova Scotia (2), Ontario (5), Manitoba (6) AND (Intervention Code is 1VA53^^, 1SQ53^^, 1VG53^^ or 1VP53^^) AND (Status Attribute is P or R) AND OOH Indicator is blank then all occurrences of Intervention Joint Identifier cannot be blank.

20 00 16: If (Intervention Code is 1VA53^^, 1SQ53^^, 1VG53^^ or 1VP53^^) AND (Status Attribute is P or R) AND OOH Indicator is blank and Intervention Joint Identifier is blank (all 20 occurrences) then Hip and Knee Prosthesis Information, Intervention Joint identifier and Revision Reason are applicable to complete.

PR-1289 Neoplasm Hard Error should be Warning

When Secondary Neoplasm was recorded (C77-C79) the following hard edit generated: If a diagnosis type of M, 1, 2, 3, W, X or Y with a diagnosis code of C77 - C79 at the 3 digit level is coded, a diagnosis type of M, 1, 2, 3, W, X or Y with a diagnosis code of C00 - C76, C80 - D09 or Z85 at the 3 digit level must also be coded.

Based on CIHI edit specs this has been changed from a hard edit to a warning.

PR-1361 Date/Time Patient Left ED

When Date/Time Patient Left ED fields were saved with an Acute Reporting Institution Type of 1 and then the Reporting Institution Type was changed to a non-acute Institution Type the values in the Date/Time Patient Left ED retained. The values will now be removed and the fields will be disabled when the Reporting Institution type is not Acute (1).

PR-1363 Type of Restraint Edit Not Generating with Patient Subservices

When Psychiatric sub-services (example: 641 or 651) were entered an edit did not generate if Type of Restraint was left blank. This has been corrected.

PR-1380 Incorrect Edit: Intervention Start Time

When an intervention start date was repeated in another occurrence (intervention location = 01 or 08) and intervention start time of 9999 was used in the second occurrence with the same intervention date the following edit was generating incorrectly:

If the Intervention Location Code is 01 or 08, the same Intervention Episode Start Date with the same Intervention Episode Start Time must not be repeated on the same abstract.

This has been fixed and will not generate for blank times (9999).

NRS RPG Grouper

PR-1366 NRS RPG Grouper Discrepancy

An issue was identified where WinRecs was calculating the RPG weight based on the Length of Stay minus service interruption days. This has been corrected to calculate the RPG Weight based on the total LOS from admission date to discharge date (including service interruption days).

PR-1329 Modify Project 250 Question 1

For Both DAD and NACRS versions of project 250, there is a correction to Question 1 Metal Stent. The CIHI value has been changed to equal "M" for metal stent. Previously it was set to "P".
