EN-1430 NACRS Clinic Lite Enhancement

In consultation with CIHI, MED2020 was advised that while Ontario clients were instructed to use one of the following MIS codes for the Clinic Lite Bundling projects, 713508545 (Care Group CL) or 714500000 (Care Group OT), they cannot guarantee sites will use these numbers. Additionally, sites may choose to submit other types of Clinic Lite cases with an Ambulatory Care Group type of CL (Clinic).

As the sites use the same Institution number for both Clinic Lite and Level 3 submissions MED2020 has no way to distinguish between the CL (clinic) cases that are actual Clinic Lite cases as opposed to Level 3 cases and can potentially affect submissions. Considering this the following changes will be in 295.3.0:

- 1) A new field will be added called NACRS Clinic Lite submission
- 2) If Ambulatory Care Group = OT or DI this field will automatically populate the new field with a Y. Ambulatory Care Group types OT or DI can only be submitted for Clinic Lite.
- 3) If the Ambulatory Care Group = CL clients will now be prompted with a Question: Is This a Clinic Lite submission. Answering Yes will populate a Y in the NACRS Clinic lite submission.
- 4) Clinic Lite Submissions will only pick up the CL cases that have a Y in the NACRS Clinic Lite submission field.
- 5) All other clinic cases will be submitted as Level 3.

For sites that populate all NACRS Lite field values via interface with no coder input this will require a modification to your interface to populate the NACRS Clinic Lite Submission field with a Y. Please contact Client Services for a quote on the interface modification – updated specs and test sample must be submitted prior to the quote being sent.

A new Care Type has been added in the Submissions and Corrections Modules: B-C-Lite: Clinic Lite (CL, DI, OT).

When this Care Type is used the submission level will default to 0.

The new field NACRS Clinic Lite submission has also been added to all I10_Amcare* views.

CodeFinder Integration

PR-1400 3M Bridge: WinRecs Day Surgery Intervention Defaults

The Intervention Start/End dates, Provider number/specialty defaults in the DAD Day Surgery intervention multiform were being removed when exiting the codefinder. This issue has been resolved.

PR-1413 3m Codefinder Issue

When the 3M Codefinder was used with the OMHRS module the codefinder would crash. This was due to new fields in place that were not expected and has been fixed.

Continuing Care (CCRS)

PR-1424 Control Header Issues with Clinical Submissions

An issue was identified for CCRS and OMHRS submissions in the control file header with values starting in incorrect start positions. This issue has been corrected

ED-1402 Abstract Profile Crystal View

For clients that have created Abstract Profiles for the Amcare or Inpatient modules, two views have been created called I10_Amcare_Profile_VR and I10_Abstracting_Profile_VR. These views will extract the Profile visit information.

ED-1408 DAD Special Project 012

DAD Special Project 012 has been added to the Projects Table . In addition the following enhancement was added to accommodate Special Project 012:

- 1) Encounter Number field (non submitted field) has increased in field size from 16 to 20 as the per the specs for the field size for the project.
- 2) A new field has been added to the Institution Profile: "Auto populate Project 012 From ENC#" with the following options:

N - No

Y – Yes, only once

U -Yes, update when Encounter Number is changed

Clients who wish to auto-populate Project 012 must have a value of Y or U in this field.

3) After entering encounter number in the encounter number field, Project 012 and the encounter number will populate in the first blank project occurrence. For records that populate the encounter number via interface the project will auto-populate when the record is loaded.

PR-1414 Extent Attribute Edit Not Generating

The below edit only generated when Intervention Code 1GZ31CA* is entered with intervention attribute extent value of 0. This issue has been corrected to look at intervention codes 1GZ31CA, 1GZ31CRND or 1GZ31GPND in combination with attribute extent value 0.

Error 110534: If an Intervention Code of 1GZ31CA, 1GZ31CRND or 1GZ31GPND is coded then Extent Attribute cannot be 0.

PR-1419 CJRR Hard Error-Coded Component

A hard error was triggering incorrectly when coding CJRR: "Coded Components must be unique if (Intervention Code is 1VA53, 1SQ53, 1VG53 OR 1VP53) AND (Status Attribute is P or R) AND OOH Indicator is blank AND (Joint Identifier is coded and valid)". This has been corrected.

Mental Health (OHMRS)

ED-1392 New 2018 DSM-V tables

OMHRS DSM-5 code table was updated which includes numerous code description changes as well as one new code: V71.09 (No diagnosis or condition).

Same Day Surgery (SDS)

ED-1415 Allow Blank Anesthetic Type for Cancelled Day Surgery

For DAD Day Surgery cases when cancelled is entered as the intervention code the anesthetic type automatically defaults to 8. While WinRecs allowed the value to be changed it will not allow the visit to be saved with no value. The system will now allow a blank anesthetic type when intervention code = cancelled.

ED-1409 V1.6 DAD Institutions and Types

The V1.6 DAD Institutions and Types table has been added to the Institution Look up table.

ED-1443 Institution Type Change for Ontario Institution Number 59950

Institution Type 59950 has been changed from C to J. Clients can now use this value in the Amcare Institution To field in combination with visit disposition 16.

To accommodate Clinic Lite Submissions a new Care Type has been added in the Submissions and Corrections Modules: B-C-Lite: Clinic Lite (CL, DI, OT).

When this Care Type is used the submission level will default to 0.
