

Release Notes for WinRecs Version 296.0.0

Release Date: March 14, 2019

The 2019 CIHI Fiscal edits are included in this fiscal release as well as Cancer Care Changes. The OMHRS DSM-5 ICD10 table is also included in this release.

Problem fixes and enhancements have been included as outlined in the Release Notes.

This release is cumulative only after the most recent WinRecs Update has been applied and therefore must be run on WinRecs installations that are on *version 295.0.0* or greater.

Important: After all Fiscal Releases and Service updates have been applied coders should check to ensure they can see grouper values in the visits. For Citrix clients this should be confirmed on all Citrix IP addresses.

Please note that WinRecs Version 296.0.0 contains a Fiscal Grouper Engine update. Clients with the CACS and CMG+/ CACS groupers please ensure all users are able to see the grouper information within the abstracting modules after applying this update. For clients with CACS and CMG+/CACS groupers you must batch group data prior to submitting Period 01 for 2019.

ED-1447 Add New Mental Health Look Up Values

The Mental Health Look Up tables have been updated with the following descriptions: Legal Status Upon Arrival to ED (DAD Group 15, Field 15 and NACRS data element 170)

- 20 Involuntary psychiatric assessment
- 41 Youth detoxification
- 42 Youth detoxification and treatment

Legal Status at Admission (DAD Group 15, Field 16)

- 41 Youth detoxification

EN-1501 Expand size of Profile Abstract Screen

When selecting a profile abstract template to apply to a record, a screen pops up to display a list of available abstract profiles. This screen has now been expanded so that more can be displayed on screen at a time.

AmCare (NACRS)

PR-1489 CCI Applicable NACRS Attributes

A warning message has been added to the NACRS module, that states when a CCI code attribute is not applicable for NACRS and can only be used with the DAD module. An example of this is CCI code 1.UG.53.LA-PM with a status attribute of "R". For this example the status attribute of "R" can only be used for DAD records.

Chart Maintenance - CPI (Central Patient Index)

PR-1524 Chart Number Change

When doing a chart number merge and chart number alpha prefix was entered in lower case the value would also show as lower case in the visit.

The software has been modified and when any lower case alpha value is entered in Source Chart Number or Destination Chart Number it will default to upper case.

The latest version from CIHI for Fiscal 2019 DAD Institutions and Types has been added to the Institution (ICD10) table.

System Maintenance - User Profile

PR-1491 User Profile: Skip Login Screen

When Yes was entered in the Skip Login Screen field in the user profile the value would disappear upon reloading the profile although the function still worked. The value Y in Skip Login Screen field will now retain upon reloading the user profile.

Utilities - Batch Grouper

PR-1429 Ontario Clients: HIG Optimizer

When Batch Grouper is performed and the Store Optimize Data is Y, the HIG Code and HIG RIW will now be stored for the other diagnosis.

PR-1483 Batch Grouper - Set Correction

When Batch grouping and Flag records for correction = Y some sites reported all cases being flagged as corrections. This happened at sites that do not have the HIG or CACSON grouper. The HIG and CACSON values grouper values were being calculated even though the sites did not have these groupers.

This issue has been resolved.

Utilities - CIHI Submissions

ED-1469 Level 1 Warning to Include Opioid submissions

The following warning did not generate when Care Type B-E-O (ED Opioid Case) at a level 3 was run and there were still Level records that had not yet been submitted. The following warning will now also generate for Care type B-E-O:

"CIHI will not allow any Level 1 submission for any period after a Level 3 (ED) submission file has been sent. Some level 1 abstracts are not submitted in the selected period. Do you want to proceed with the Level 3 Submission File creation?"

ED-1482 Alberta Health: MACAR Submission

Fiscal 2019/20 Alberta Health (MACAR) submission changes have been included in this release.

ED-1508 Submission Provider Service Edits on Submission

When a record is opened there is an error checked to see if a service is valid and linked to the provider used. "Provider Service will be cleared because the code linked to it is invalid" and "intervention Provider Service will be cleared because the code linked to it is invalid". These errors that are checked when a record has loaded will now also be checked for during the submission process for DAD and NACRS.

PR-1088 EMT: Batch Verify

Clients with EMT can now run an EMT Batch Verify for submitted abstracts. In the CIHI Submission, 'Select Edit Library' C-Custom Edits only, 'Complete Re-verify' select S-Submitted.

PR-1473 Opioid Submission Issue

When a submission/correction is generated on Care Types B-E, B-C or B-D users can still access and code visits for the same period if the care type is different than the Care Type submission. However the system was generating the following warning when Care Type B-E-O (ED Opioid Case) was used in the submission process: The process cannot be processed because there are records from this period that are currently being accessed.

This issue has been resolved and Opioid submissions can run if different care type records are being accessed for the same period.
