

Release Notes for WinRecs Version 296.1.0

Release Date: May 23, 2019

Problem fixes and enhancements have been included as outlined in the Release Notes.

This release is cumulative only after the most recent WinRecs Update has been applied and therefore must be run on WinRecs installations that are on **version 296.0.0 or greater**.

Important:

All sites who submit both Clinic Lite (level 0) and level 3 with the same Institution Number must apply this update and make the changes outlined in **Ticket 1585** in the release notes. All coders should be informed of these changes.

After all Fiscal Releases and Service updates have been applied coders should check to ensure they can see grouper values in the visits. For Citrix clients this should be confirmed on all Citrix IP addresses.

The pdf viewer icon in WinRecs has been updated to allow viewing of other file types including txt, doc, docx, xls and xlsx.

PR-1580 Cloning Records Updates Encounter Sequence

A change has been made to the cloning process so that the field "Encounter Number Sequence" will not be cloned from the source record if the destination record already has a value in the field.

AmCare (NACRS)

PR-1555 Intervention Multiform: Copy Function

Previously, when using the Copy Function, the field "Intervention Date In" was not copying over to the next intervention. This has been fixed to now copy the "Intervention Date In" field into the new intervention occurrence when using the Copy function.

PR-1557 Cloning Records - Verify Experience Error

When using the cloning feature some sites reported getting the following error messages:
"Verify Experience Error: 53" and "Verify edits experience at step: 7"

This issue has now been fixed.

PR-1578 Duration of Main/Other Intervention Field for Unknown Times

Previously, the 'Intervention Start Time Unknown' and the 'Intervention End Time Unknown' fields did not update the 'Duration of Main/Other Intervention' auto-calculation field. Now, if the 'Intervention Start Time Unknown' or the 'Intervention End Time Unknown' field = Y, it will auto populate the 'Duration of Main/Other Intervention' field to 9999.

Continuing Care (CCRS)

ED-1569 CCRS: Residence Code

A new field called Residence Code has been added to the CCRS Admission assessment. This is for internal reporting only and the value will not be submitted to CIHI.

PR-1558 MDS Assessments: Input Date and Time

The Data Entry Coder, Input Date and Input Time will now populate when a new MDS assessment is created.

Inpatient (DAD)

ED-1540 CMG Optimizer: Weight in Kg

The field "Weight in Kg" has been added to the CMG optimizer screen.

Mental Health (OHMRS)

PR-1583 OMHRS: Error 11 - Division by Zero

The following OMHRS error was reported by one user: Error 11 - Division by Zero
The site nor MED2020 could duplicate the error however a check was added to N1a after it converts into number from string.

NACRS Clinic Lite

ED-1571 Submitted Record Message NACRS Lite

After a NACRS Lite record was submitted the following message was not displaying upon loading the visit: 'This record has been submitted to CIHI for Level 0/1/2. Any changes will be part of the current fiscal year correction'.

This message will now appear after a NACRS Lite has been submitted.

EN-1585 Change to Flagging Level 3 VS Clinic Lite Visits

Clients who are submitting both Level 0 (Clinic Lite) and Level 3 must make the following change:

A new field has been added to the MIS Code Look Up table in Look Up Field Maintenance called: Submit Clinic Lite. Sites must add a Y to this new field for all MIS Codes used for NACRS Clinic Lite visits. Visits that use MIS Codes that have been flagged as "Submit Clinic Lite" will be submitted as Level 0. Visits that use MIS Codes that have not been flagged as "Submit Clinic Lite" will be submitted as Level 3.

Note: The Prompt has been removed asking if this is a NACRS Clinic Lite visit.

Important: Once a visit is submitted the MIS code cannot be changed to a different submission level. The following hard error will display if a user tries to change the submission level MIS code: You cannot change the MIS code to a different submission level. A deletion must first be sent as Clinic Lite (Level 0) or Level 3 and then create a new visit. Please change back to original MIS Code.

NRS RPG Grouper

PR-1562 2019 RCG Weights Not Calculating

The RCG weights were not calculating in the 2019 NRS assessments. This issue has been resolved.

The CIHI version 1.4 DAD Institution and Type table is included in this release.

System Maintenance - Provider Maintenance

ED-1567 Provider Maintenance: MOH Code

In the Provider maintenance module the MOH code field has been changed from numeric to alpha-numeric and field length has increased to 15.
