



Release Notes for WinRecs Version 296.2.0

Release Date: September 26, 2019

Problem fixes and enhancements have been included as outlined in the Release Notes.

This release is cumulative only after the most recent WinRecs Update has been applied and therefore must be run on WinRecs installations that are on **version 296.0.0 or greater**.

Important:

NRS: There has been a change to the Rehab Grouper (see PR-1606). All sites who have the RPG grouper should batch group all of their data to adjust the LOS calculations.

The latest version of DAD and NACRS CIHI 2019 Fiscal edits are included in this service release.

After all Fiscal Releases and Service updates have been applied coders should check to ensure they can see grouper values in the visits. For Citrix clients this should be confirmed on all Citrix IP addresses.

A new field called Hospital Account Record (HAR) has been added to the following modules:

Inpatient, SDS, NACRS, CCRS, Rehab, OMHRS and Visit History. This field can accommodate a LHIN with a shared registration system. This field is not submitted to CIHI. The field must be enabled in the control file.

ED-1547 Code Basket Multiple Folio Sessions Accumulating

Previously when using the Folio code basket to send codes back and forth between Folio and WinRecs, a new session of Folio would launch each time Folio was accessed from the diagnosis or intervention multi-forms. With this change, Folio will close when the codes are imported back into WinRecs which will result in only one session of Folio running.

ED-1603 Ontario: Special Project 065

Project 065 (DAD) and Project 065 (NACRS) have been added to the Project table in Look Up maintenance as well the following two views have been added: I10_Projects_065_VR and I10_Amcare_Projects_065_VR.

Note: In this release once the Bundled Care Type is chosen in Question 1 (DAD) and Question 145 (NACRS) the value will auto-populate (DAD – Questions 1 to 6) (NACRS Questions 146-151).

If clients built this project they must disable and use the MED2020 project in order for the aut-populate feature to work.

ED-1661 MB Health: Generic Institution Edit update

The following Manitoba Health edit has changed to also allow MB facility number 8002 in combination with Institution To 60999:

For Generic Institution 60999 (acute out of country) please change the edit so that the coder can enter the facility number 9999 or 8002 (Roseau Area Hospital)

AmCare (NACRS)

PR-1650 Abstract Profile Doesn't Set NACRS Lite Flag

When a NACRS lite record is copied to another record using the abstract profile function, the NACRS lite flag will now also populate when the profile is applied.

PR-1683 NACRS Lite: Unable To Clear Submission With MED2020 Coder Profile

When logged in with the MED2020 Coder Profile the option to clear Clinic Lite Submissions was not working.

This has now been fixed.

Cancer Care (CCM)

PR-1667 CCM Staging Issue

The TNM staging fields were not opening for certain topography codes. CCO had updated tables in the databook and these changes have been added to the Cancer Care tables in this release to resolve this issue.

CodeFinder Integration

ED-1593 3M Bridge Needs New Tag (EPISLOC)

3M bridge was not processing the new tag (EPISLOC). This has now been added to the processing rules and inbound/outbound packets now process (EPISLOC).

EN-1612 Date/Time Stamp For 3M Codefinder and FOLIO

Date/Time fields will be stored to allow sites to collect the date/times in and out when accessing either Folio or Other Codefinder via the diagnosis or intervention multiforms. A new view has been added called Sec_EncoderLog_VR to report off of this information.

PR-1591 3M Bridge Not Triggering Specific Code Conditions

In the 3M Codefinder certain fields that should open or close dependent upon the code selection were not doing so forcing a re-verify (F11) as a workaround.

In this release after populating the diagnosis and intervention, WinRecs will automatically trigger the validation for CIHI Submitted field validation.

Continuing Care (CCRS)

ED-1621 Remove the MDS2.0 Facility File Information Option

In 2012 CIHI Discontinued the MDS 2.0 Facility Information File and replaced it with the Contact Information file (record type CI). Under utilities the option to choose MDS 2.0 Facility Information File was still enabled which led to confusion to clients. This option has now been disabled.

PR-1686 CCRS: Discharge No Assessment (L08) Issue

When running the CCRS submission clients reported it showed X amount of records being processed however when the file was created there were no cases in the file. This issue only occurred when L08 -Discharge No Assessment was in a different quarter than the OA -Admit Background Assessment.

The scenario was as follows:

- Admission June 30 (Q1) and Discharge No Assessment July 2 (Q2).
- When the Q1 submission was run it was also including the discharge in the count for records processed however the L08 was not included in the Q1 submission file.
- When the Q2 submission was run the Discharge No Assessment is picked up and included in this submission.
- If the Q1 submission is run again (corrections, etc) it will again show the L08 as being processed in the count even though it is not included and if the L08's are the only cases flagged as corrections it will create the empty file.

This issue has been resolved to ensure when the L08 falls into a different quarter than the admit background the L08 will not be included in the Records Processed count for the quarter that includes the Admit Background.

Crystal Views

ED-1617 View to Extract Date/Time Stamp For 3M Codefinder and FOLIO

A new view called Sec_EncoderLog_VR has been created. This view will extract values when the user is in the Diagnosis or Intervention multiform and clicks the 'Other Encoder' or 'Folio' icon. It will record the coder, module, start/end date and time and duration. This view must link to the I10_Amcare or I10_Abtracting views.

ED-1659 Add views for DAD and NACRS for Project 315 and Question 1-5

Added views I10_Projects_315_VR and I10_Amcare_Projects_315_VR to extract Project 315 and specific questions. These views would link to the I10_Abstract or I10_Amcare views.

ED-1660 Add views for DAD and NACRS for Project 316

Added views I10_Projects_316_VR and I10_Amcare_Projects_316_VR to extract Project 316 and specific questions. These views would link to the I10_Abstract or I10_Amcare views.

ED-1681 OMHRS Rule 20310 (Error Code 002665) Removed

The following Rule and Error has been decommissioned by CIHI and removed in WinRecs:

Rule 20310: IF Z1 Record Type = 5 and [X2 Submission Type = N or C] THEN at least one DSM-5 code must be entered.

Error Code 002665: Invalid DSM-5 Code. At least one code must be entered when (Z1) Record Type = (5) Discharge on a New or Correction Submission

NACRS Clinic Lite

ED-1619 NACRS Clinic Lite: Revisions to Projects 960 to 966 Ontario Bundled Care

The following changes have been made for Projects 960 to 966 (Bundled Care):

Diagnosis Prefix I and J have been disabled

Diagnosis Prefix D and K have been added

PR-1601 Incorrect Edit Amcare Reg/Encounter Sequence Number

Error message "If Ambulatory Registration/Encounter Sequence Number is coded, it must not be 000 and must be entered 001-999" was incorrectly firing when the field was blank, this has been corrected for edit to display only when value is invalid.

PR-1669 Duration of Ambulatory Care Intervention Error for Level 0

Missing edit on Clinic Lite Records, "Duration of Ambulatory Care Intervention coded but no corresponding Intervention". The error message will now display when applicable, for level 0 records.

NRS RPG Grouper

PR-1606 Rehab - LOS And RPG LOS Not Calculating Correctly

Rehab LOS Days (main grid field) and RPG LOS Days (FIM/RPG grouper calculation box) were not calculating correctly.

LOS Days on the main grid will now calculate as follows:

(Element 21) Admission Date to (Element 30) Discharge Date, minus any Service Interruption LOS Days.

Inclusions/exclusions: Length of Stay excludes Service Interruption Days but includes Days Waiting for Discharge

This is the value that will display on LOS field from all Rehab views except the RPG views LOS.

The RPG LOS will now calculate as follows:

(Element 21) Admission Date to (Element 30) Discharge Date and include Service Interruption LOS Days in addition to including Days Waiting for Discharge

This is the value that will display on LOS from all RPG Views. RPG Weight is based on this LOS calculation.

Important: As a change has been made to the FIM Grouper all sites with the FIM Grouper must regroup their data.

PR-1656 Runtime Error 94 - NRS Assessments

When the discharge and admission assessment linkage is broken a run time error will occur when trying to pull up the discharge assessment. This requires a wru patch to delete the discharge assessment.

The following message has been added to avoid having to obtain a wru patch:

The select discharge assessment does not have proper admission assessment linkage. It will cause a runtime error. Do you want WinRecs to purge the record from database?

Note:

- 1) If the discharge assessment has not been submitted it will be automatically purged.
- 2) if the discharge assessment has been submitted the assessment will get sent to the purge module
- 3) The user must have "Delete" permissions.
