

# Release Notes for WinRecs Version 297.0.0

Release Date: March 12, 2020

2020 Fiscal edits are included in this fiscal release for DAD, NACRS, OMHRS and Cancer Care. Note: OMHRS includes a new data element for 2020 Fiscal Year: (X141) Discharged With

Support/Referral for Home Care Services.

Problem fixes and enhancements have been included as outlined in the Release Notes.

This release is cumulative only after the most recent WinRecs Update has been applied however the update must be applied on minimal *version 296.0.0* or *greater*.

### **Important:**

After all Fiscal Releases and Service updates have been applied coders should check to ensure they can see grouper values in the visits. For Citrix clients this should be confirmed on all Citrix IP addresses.

Please note that WinRecs Version 297.0.0 contains a Fiscal Grouper Engine update. Clients with the CACS and CMG+/ CACS groupers please ensure all users are able to see the grouper information within the abstracting modules after applying this update. For clients with CACS and CMG+/CACS groupers you must batch group data prior to submitting Period 01 for 2020.

# PR-1710 3M Bridge: Blank Occurrences Not Processing

When Intervention code was blank in WinRecs and Anaesthetic Technique had a value in the intervention multiform the 3M bridge populated the 3M intervention code with XX.

This will no longer happen and the bridge will now ignore blank intervention codes.

In addition Anesthetic Technique will not be overwritten when the returning packet is blank for that field

#### PR-1691 I10\_Amcare\_Projects\_316\_VR Issue

The I10\_Amcare\_Projects\_316\_VR was returning wrong values on reports and when used in combination with

the I10Amcare\_VR all data was removed from the report. The I10\_Amcare\_Projects\_316\_VR is now returning correct values and data is retained when this view is used with the I10Amcare\_VR.

#### PR-1699 Rehab LOS Days Not Displaying Correctly In Crystal

When using Rehab Views the LOS days displaying on the report were incorrect and included service interruption days. This has been corrected and the LOS Days from main Rehab Views will now display the LOS days as follows:

(Element 21) Admission Date to (Element 30) Discharge Date, minus any Service Interruption LOS Days

#### PR-1768 Edits Management Tool: Regional Setting Display Date

If computer Region Settings Short Date format is set to dd-MMM-yy and in the Edits Management Tool the Valid To date is saved as 2099/03/31 it displays the year as 1999.

This has been resolved and the valid to date will now show as 2099 in EMT.

MB Health 2020 Fiscal Change: When ALC Reason value of 46 is used it must be used in combination with ICD-10-CA diagnosis codes Z76.2 or Z76.3

### ED-1774 MB Health: Institution/discharge Combination

#### PR-1744 3M Coderfinder: Maternal Newborn Chart Number Removed

On initial save in an obstetrical chart where codes were chosen from 3M codefinder the maternal newborn chart number retained. If, however, the user has to make changes and went back into the 3m codefinder a second time upon exiting the maternal newborn chart number is removed from the abstract.

This issue has been fixed and the maternal newborn chart number will now retain.

### PR-1778 Incorrect Hard Error: DAD CJRR Component

When intervention code 1.VA.53.LA-SL-N was coded and Status attribute = R and Component was left blank the following incorrect edit was generating:

If (Intervention Code is 1VA53^^, 1SQ53^^, 1VG53^^ or 1VP53^^) AND (Status Attribute is P or R) AND OOH Indicator is blank AND (Joint Identifier is coded and valid) AND (not 1VA53LLSL^ or not 1VA53LASL^) AND (not 1VG53LASL^) then at least one Component must be coded

This issue has been resolved to exclude mandatory component when intervention code coded at the 8th digit level has SL^ and status attribute is P or R and OOH is blank.

#### **Mental Health (OHMRS)**

#### PR-1716 OMHRS - Missing OMHRS Rule 20630

The following edit was not generating:

Rule 20630: IF Z1 Record Type = 5 and [X2 Submission Type = N or C] and [X90 Discharge Reason = 1] and [(X80 Discharge Date - CC1 Date Stay Began - X130 Total Days Away from Bed) > 6] THEN Q2a - DSM-5 code must not be blank.

The edit is now working correctly in version 297.

# PR-1776 OMHRS: Hard Edit Should Be Warning

The following message was generating a hard edit and should have been a warning. The message will now generate as a warning only:

IF Z1 Record Type = any of (4, 5, 6) and Q1v = blank on Admission Assessment with the same AA4 Facility Number, X30 Chart Number and AA3 Case Record Number THEN Q1v DSM - Not Applicable should not = 1
