

Release Notes for WinRecs Version 297.0.1

Release Date: May7, 2020

Problem fixes and enhancements have been included as outlined in the Release Notes.

This exe patch is cumulative only after the most recent WinRecs Update has been applied however the update must be applied on minimal *version 297.0.0* or *greater*.

Important:

- Important changes have been added to the CIHI Submissions/Corrections module see ticket ED-1804.
- After all Fiscal Releases, Service updates and exe patches have been applied coders should check to ensure they can see grouper values in the visits. For Citrix clients this should be confirmed on all Citrix IP addresses.

Please note that WinRecs Version 297.0.1 contains a Fiscal Grouper Engine update. Clients with the CACS and CMG+/ CACS groupers please ensure all users are able to see the grouper information within the abstracting modules after applying this update. For clients that did not apply the two wru patches for COVID-19 Grouper updates please batch group all 2020 DAD and NACRS after applying this update.

NRS Sites that did not apply the wru patch to address the issue in ticket PR-1789 should batch group all 2020 NRS assessments after this update has been applied.

When Health Card Number Status = 8 Unknown or 9 Not Applicable the HCN Field would disable but the following hard edit would display: "Health Care Number Is Invalid According To Province Of Issue"

This edit has been removed.

NRS RPG Grouper

PR-1789 NRS: No Grouper Weight for 2020 Assessments

Admission and Discharge Assessments for Fiscal 2020 were display 0 for the RPG Weight. This issue has been resolved.

ED-1792 Updated NRS ICD10CA Picklists

The NRS ICD10CA Picklist has been updated to include COVID-19 diagnosis codes U07.1 and U07.2.

RUG

ED-1797 CCRS: RUGS Grouper Default

The RUGS 44+ grouper was added in version 297 and upon opening CCRS assessments the default grouper showing was RUGS 44+. The grouper default will now be RUGS 44.

System Maintenance - Look Up Profile

ED-1786 Updated CED-DxS (ED DIscharge Diagnosis) Table

The CED-DxS (ED DIscharge Diagnosis) Table has been updated to include the following diagnosis codes:

U07.0 - Vaping-related disorder

U07.1 - Coronavirus Diseases 2019, virus identified

U07.2 - Coronavirus Diseases 2019, virus not identified

ED-1801 Updated Institution and Types Table

The ICD10 Institution and Types table has been updated to include version 1.3 and 1.4 from CIHI.

Utilities - CIHI Submissions

ED-1804 COVID-19 Submissions/Corrections and DAD Partial Submissions

The following features have been added to WinRecs Submission and Correction Modules: DAD Submissions/Corrections:

- 1) WinRecs now allows partial submissions for the period. Date Fields are enabled so users can select the from and to dates for the period they are submitting. For the time frame selected all visits must be saved with no errors.
- 2) Under the Care Type field two care type options have been added: 1) All DAD cases 2) COVID-19 only
- 3) When "COVID-19 Only" care type is selected only cases with diagnosis codes U07.1 (virus identified) and U07.2 (virus not identified, suspected COVID-19) will be included in the submission. Sites can choose the time frame for the period they are submitting. All COVID-19 visits for that time frame must be saved with no errors.

NACRS Submissions/Corrections:

- 1) Under Care type a new care type called B-E-COVID-19 (ED COVID-19 case) has been added for Level 1, 2 and 3 ED cases.
- 2) When the above care type is selected only COVID-19 ED cases with U07.1 (virus identified) and U07.2 (virus not identified, suspected COVID-19) will be included in the submission. For Level 2 the submission will look at ED Discharge Diagnosis.
