## Ticket Details

### Continuing Care (CCRS)

#### ED-1820 CCRS: Section G Fields Disabling Incorrectly for Comatose Patients

In CCRS when Element B1 Comatose = Y multiple fields would auto-populate with the value 8 and disable in Section G—Physical Functioning and Structural Problems . Now when Comatose = Y the fields will continue to auto-populate however the fields will no longer disable to allow different values.

Exception: Fields G3a, G3b, G5a, G5b, G7, G8a, G8c will continue to default with a value of 8 and disable based on edits between Comatose =Y and these fields.

### Inpatient (DAD)

#### PR-1828 DAD: Weight In Kilograms Allowing Comma

If a comma was accidentally entered in DAD Element 03-29: "weight in kilograms" WinRecs allowed the entry of the comma as in this example: "5.,69". This issue has been resolved

When a report was run using the WeightKG field a "converting data varchar to numeric" error occurred if a weight in kilogram value had a comma. The I10\_Abtracting views have been updated to resolve this issue.

### Mental Health (OHMRS)

#### PR-1824 OMHRS: Critical Error

When loading interfaced OMHRS assessments or manually creating OMHRS assessments the following Critical Error was generating:

Error Number: 13

Error Description: Type Mismatch

This issue has been resolved.

### System Maintenance - Look Up Profile

#### ED-1815 Fiscal 2020 DAD Institutions and Types V1.5

The Institution ICD-10 Look Up Table has been updated with Fiscal 2020 DAD Institutions and Types V1.5.

### Utilities - CIHI Submissions

#### ED-1821 DAD Partial Submissions Work Like NACRS

DAD partial submissions will now work like NACRS partial submissions. For the time frame selected the system will allow completed cases to be submitted and bypass incomplete cases.

#### ED-1823 DAD Covid Only Submissions for 2019

When running a DAD submission and choosing care type" COVID-19 Only" this selection did not work for Batch Year 2019.

Sites can now run COVID-19 Only DAD submissions for Batch Year 2019.
