



Release Notes for WinRecs Version 297.2.0

Release Date: September 24, 2020

Important:

A new CCRS data element has been added to the CCRS discharge assessment: R3c - Covid-19 Status. This field will be mandatory on all discharge assessments effective October 1, 2020 however clients can still submit values prior to this date as optional.

The E-specification version in the CCRS submission file has changed effective October 1, 2020. Sites submitting CCRS files on or after October 1 must be on WinRecs **version 297.2.0** to submit the correct E-specification version.

Problem fixes and enhancements have been included as outlined in the Release Notes.

This release is cumulative only after the most recent WinRecs Update has been applied however the update must be applied on minimal **version 297.0.0** or greater.

After all Fiscal Releases, Service updates and exe patches have been applied coders should check to ensure they can see grouper values in the visits. For Citrix clients this should be confirmed on all Citrix IP addresses.

All Abstracting

ED-1833 Auto validation when exiting 3M CAC/Folio Basket

Currently when populating the diagnosis and intervention codes with 3M CAC/Folio Basket WinRecs automatically triggers the validation for CIHI Submitted field validation. Sites can now choose between automatic validation or manual validation with the F11 option.
A new field has been added to the Hospital Profile called "Auto validation when exiting 3M CAC/Folio Basket" and is defaulted to No. This field needs to be enabled in the Hospital Profile Module in the Control Module.

The field options are:

Yes = All CIHI submitted intervention and diagnosis field auto-validation will occur upon exiting 3M CAC/Folio Basket.

No = Validation only occurs when the user does a F11 verify.

ED-1883 Add 90105 to Patient Service 76

Institution number 90105 has been added to the list for the following edit. 'If the first character of the institution number is British Columbia (9) and the institution number is not on the specified list of institution numbers valid to use patient service 76, the main patient service must not be 76'

ED-1855 NACRS Fiscal 2020 Vendor Edit Specs V1.1 - CDU Date In

CIHI issued a modification on Element 123: Clinical Decision Date Unit In as follows:
If the CDU Date/Time In (DE 123/124) and the Disposition Date/Time (DE 114/115) are both coded and valid, the CDU Date/Time In (DE 123/124) must be prior to Disposition Date/Time (DE 114/115). Note: Only the date values are compared if one or both times are unknown (9999).

The change includes looking at date values only if one or both fields have a time of 9999.

PR-1890 Additional Blood fields not disable when Transfusion Given N

Blood fields element ID 177-185 will disable when Transfusion Given is N.

Cancer Care (CCM)

ED-1867 CCM: Updated CCO Regimens

The CCM CCO Systemic Drug Delivery Event Regimen code table has been updated and are accessible under the header CCM Systemic Drug Delivery Event.

PR-1866 Cancer Care - CMIR Field Incorrectly Triggering as Mandatory

The CMIR Field in Cancer Care was incorrectly triggering as mandatory. Clients can now leave this field blank without an error triggering.

PR-1880 Drug Delivery Multiform disabled if CCM Chemo Flag is blank

If an Amcare visit is linked to a Cancer Care Registry, it will enable related Cancer Care fields in the abstract. In order to enable the CCM Systemic Drug Delivery multiform, the CCM Chemo Flag must be Y. The CCM Chemo Flag field is not submitted to CCO. The CCM Systemic Drug Delivery multiform will remain enabled by default and will no longer rely on the CCM Chemo Flag field.

The following field has been added to the Central Patient Index View: High Risk

EN-1854 CPI Chart volume: Destruction Date/Updated Central_Patient_Volume_VR

A new field called Destruction Date has been added to Chart Volumes.

To activate this field :

1. Go to Control File
2. Select Coder Number
3. Select CPI Volumes under modules
4. Highlight the Destruction Date field and click on F6
5. Enter Y in the "Is Field Enabled" and "Is Field Visible" fields and save

When a date is entered in the Destruction Date field in chart volumes the information for the volume/s will display in red.

Destruction Date Field has been added to Central_Patient_Volume_VR.

Chart Maintenance - ROI (Release of Information)

EN-1863 ROI: High Risk Warning

A new field has been added to the Central Patient Index (CPI) module called "High Risk". If the "High Risk" field in CPI is set to Yes when this chart number is loaded in the Release of Information Module (ROI) the following popup warning will generate:

HIGH RISK RECORDS- Review Records/ROI Section in chart for more Information prior to Release Records

Please note the High Risk field must be enabled in the Central Patient Index Module (CPI) in the Control File.

Valid Look up values:

- 0 Positive test

- 4 Not tested

NOTE: This field will be mandatory on all discharge assessments effective October 1, 2020 however clients can still submit values prior to this date as optional.

PR-1857 CCRS RUG 44: Wrong Values Display on Load

Upon initial load of a CCRS Assessment the RUGS 44 button showed the default however it was the RUGS 34 grouper values that displayed. The correct RUGS 44 values would display upon reload of RUGS 44 grouper or the CCRS assessment.

This issue has been corrected. When loading a CCRS assessment the RUGS 44 grouper values will now default.
