This release is cumulative only after the most recent WinRecs Update has been applied however the update must be applied on minimal version **297.0.0** or greater.

Important:

Please note that WinRecs Version 298.0.0 contains a Fiscal Grouper Engine update. Clients with the CACS and CMG+/ CACS groupers please ensure all users can see the grouper information within the abstracting modules after applying this update. For clients with CACS and CMG+/CACS groupers you must batch group data prior to submitting Period 01 for Fiscal Year 2021.

After all Fiscal Releases and Service updates have been applied coders should check to ensure they can see grouper values in the visits. For Citrix clients this should be confirmed on all Citrix IP addresses.

When "Auto validation when exiting 3M CAC/Folio Basket" field is set to No in the Hospital Profile the Intervention Provider Service/Specialty was not populating when exiting the 3M CodeFinder. This issue has been resolved.

Continuing Care (CCRS)

PR-1916 CCRS: Incorrect Hard Error for Element F3c

On the Annual Full Assessment when a value of 9 was assigned to Element F3c: Perceived daily Life is very different - the following incorrect edit was generating:

Resident perceives daily life (customary routine) is different from prior pattern in the community has an invalid code. Valid Codes are 0, 1,8.

When a value of 9 is now entered for Element F3c the following error will generate:

Resident must be assessed for perception of daily life compared to prior pattern in the community (F3c = 0 or 1) for annual full assessments or significant change to a full assessment (AA8 = 2 or 3). Does not apply to comatose residents (B1 = 1).
