Important:

NRS Clients: There is a FIM/RPG grouper update in this release. All 2021 assessments should be batch grouped after applying the update. **(Ticket WR2-24)**

After all Fiscal Releases and Service updates have been applied, coders should check to ensure they can see grouper values in the visits. For Citrix clients this should be confirmed on all Citrix IP addresses.

WR2-26 Default Diagnosis Type 9 With Diagnosis Code U077

Diagnosis type 9 will now default with Diagnosis Code U077.

WR2-35 Manitoba Health - 2021 Updated Rule

Rule adjusted to allow Institution 69698 with discharge disposition code 40 and MH Facility number 9999.

WR2-39 Reproductive Fields Not Enabling

Reproductive fields remain disabled when associated Obstetrical Diagnosis and Intervention fields are brought over from the 3M Codefinder and only enabled upon F11 or save. This issue has been resolved.

WR2-46 Incorrect Episode Duration Warning

When more than one intervention occurrence is entered and Start Time and/or End Time = 9999 the following incorrect warning was generating: If the episode start date and time and episode end date and time are coded and valid and neither time is 9999 the difference between the two dates in minutes should be less than 1440. The warning has been removed.

WR2-12 Institution To Field Not Enabling

In NACRS when Visit Disposition values of 06, 07, 08, 09, 30 or 40 were entered the Institution To field did not automatically enable forcing the user to F11 verify or save to enable this field. This issue has been resolved and the field will now automatically enable with these Visit Disposition values.

Cancer Care (CCM)

WR2-49 Staging Version 08

When entering a new Disease Registrations Staging version 08 did not display as a Look Up option in the Staging Version field. Once the registration date was entered the value was then available. The Staging Version field will now default to 08 on new Disease Registrations.

WR2-50 Staging Fields Not Enabling

For new Disease Registrations the Staging fields did not enable for 2020 registrations. This issue has been resolved.

Chart Maintenance – CPI/ROI (Release of Information)

WR2-27 ROI Legal Comments

ROI Legal Comments field has been added to the Central Patient Index module and the ROI module. When the field is modified in either CPI or ROI the field will also update in the other module.

CIHI Submissions

WR2-53 Record Count Discrepancy

When running a submission verification for NACRS Level 3 (all care types) the system generated a Record Count discrepancy warning for visits with no MIS codes which have Care type B only. These visits were not included in the verification. The MIS code assigns the Care Types and the submission process looked only at Care Types B-C, B-E, B-D, B-C-Lite, B-E-Covid-1 and B-E-O. The care type of B has been added to the verification and these types of cases will now trigger an error during the submission verification.

Continuing Care (CCRS)

WR2-22 Medication Days Received Fields Not Enabling

When populating values in the Number of Medication and Number of Days Injections Received fields, the Days Received fields remained disabled and only enabled upon F11 or save. This issue has been resolved.
