

Release Notes for WinRecs Version 2025.01

Release Date: March 20, 2025

The 2025.01 Fiscal Release includes fixes for reported issues as well as enhancements.

This release is cumulative only after the most recent WinRecs Update has been applied however the update must be applied on minimal version 2024.01 or greater.

For those sites with CMG and CACS Groupers, the 2025.01 Release contains a Grouper Engine update. Fiscal 2025 DAD and NACRS Level 2/3 abstracts must be batch grouped prior to submitting 2025 Period 01 files to CIHI. A warning message indicating "No Grouper value..." will display should the record not be grouped with the current grouper year.

PR_25060 Transfer Worksheet: Warning for Transfer Overlapping Dates

On Transfer Worksheet a warning will generate when Transfer Dates overlap.

PR_25069 Transfer Worksheet: Transfer Days Calculating Incorrectly when Times Entered

The length of stay (days) on the Patient Service Transfer Worksheet is derived by subtracting the start date of one service from the start date of the immediately subsequent service or, for the last service to which the patient was

assigned, subtracting the start date of that service from the separation date. If consecutive start dates are the same, the LOS = 0 for that service transfer. The LOS days were calculating incorrectly when transfer times were entered. This has been corrected, and the calculation will only look at start and end dates.

PR_25146 Responsibility for Payment 01 and HCN Province

Responsibility is 01-Province/Territorial Responsibility and HCN Province is not the province of submitting Facility, a hard error will not generate instead of a warning.

PR_25067 Unable to Merge/Relocate CCM Visits

When merging charts or relocating visits, CCM visits werenot being included and remained in the Source Chart. This has been corrected, and CCM visits can now be moved to the Target Chart number.

In Amcare Level 1 module when Admit by Ambulance is <> N and Ambulance Arrival and Transfer Care Date and Time fields are blank a warning will now display instead of a hard error.

PR_25117 CCRS Section G Transfer Edit

An edit for Transfer Performance has now been fixed, that was not triggering previously. If 'Transfer Support Provided' = 8 then Transfer 'Self Performance' must also = 8.

PR 25190 Unable to create MDS 09 When MDS 09 and MDS 07 Have Same Visit Date

When two previous assessments (MDS 09 and MDS 07) had the same visit date, MDS 09 could not be created. This has been corrected and the MDS 09 can now be created for this scenario.

PR_25191 Marital Status for MDS 09 not coming across from previous assessment

Marital status will now populate in the re-entry admissionassessment (MDS 09) from the last admission or full assessment.
