PR 20721 Prevent Cloning Record from Setting the Disposition Date

The following fields will no longer clone: Disposition Date/time for NACRS and Discharge Date/time for DAD/SDS

PR_20811 Incorrect Edit Generating for Intervention Code 1NM87BA

When Intervention code 1NM87BA was used with Intervention Attribute Extent "PP" the following incorrect edit was generating: Intervention Attribute Extent has an invalid value and must be corrected.

When the Intervention Attribute Extent "PP" was reselected the error was removed.

This issue has been resolved.

WinRecs3\Reporting

PR_20787 Update CPI Views to Account For Address Multiform in WR3

The primary address and next of kin will no longer return duplicates when using the CPI Views.

PR_20853 Data in the CMG Views for OOH Count

The CMG views have been updated so that the Out of hospital intervention information will return values for records after 2011. This includes the fields InterventionOOHCount and InterventionOOHCountDesc..

WinRecs3\Abstracting\NACRS

PR_20792 NACRS Level 3 Search - No Record Found is not turning to Red

When doing a search for a record, No Record Found was not showing red when 'Institution To' was used to search field. "Institution To" is not a field that can be used to search on. Fields that cannot be used to search will no longer display as an option.

PR_20824 NACRS Expired Death Information Fields Remain Enabled

Expired Death Information fields remained enabled when non-death disposition codes were entered. These fields will now

only enable when a death discharge disposition code is entered.

PR_20831 Reproductive Fields Disable for Gender Male

When Gender = M Reproductive Fields will now disable.

PR_20798 Turn Off Edits for Unsupported Years

A new feature has been added to edit historical cases in the User Profile for each applicable module. For DAD/NACRS the feature is called Edit Historical (pre-2013) - for any visits prior to 2013 users must have this permission checked to resave visits prior to 2013. For CCM the feature is called Edit Historical (pre-2014).

For Clinical Modules the permissions field in the User profile is called Edit Historical (no edits). When assessments prior to the current fiscal year are loaded the user will now be prompted with the following:

This assessment is from an earlier fiscal year. Would you like to load it with the current fiscal year edits? (selecting No will open the record with no edits applied)

PR_20871 OMHRS Add 3m Bridge and Folio Buttons

In the OMHRS ICD10 diagnosis screen, there have been buttons added to launch the 3M bridge and FOLIO programs for importing codes.

PR_20801 OMHRS X160 Not Opening for Short Stay or Discharge

Element X160 Schizophrenia was not enabling when creating Short Stay or Discharge Assessments. This issue has been resolved.

PR_20862 DSM 5 Code Error for LOS <7 days

When LOS days < 7 the following incorrect edit generated: error "DSM-5 Code is a CIHI mandatory field that must be coded before submission" This has been corrected

PR_20868 Incorrect Edit on MH-Service Interruption LOS Days

When Service Interruption LOS days were entered with a valid numeric value the following incorrect hard edit generated: Service Interruption LOS Days has an invalid value and must be corrected.

This error will no longer generate when a valid value is entered in the Service Interruption LOS days field.

WinRecs3\CPI

PR_20814 Unhandled Exception Error when Doing Chart Merges On Level 1 Submissions

An Unhandled Exception Error triggered when doing Chart Number Merges/Submissions for cases that had a level 1 submission only. This was because WinRecs checked for NACRS CJRR Fields and these fields do not apply for NACRS Level 1. Chart Number changes will now skip checking NACRS CJRR except for NACRS Level 3.

WinRecs3\Abstracting\NRS

PR_20822 Enter NRS weight as 65.2 it displays as 652.00

When a value of 65.2 was entered in the NRS Weight field the value displayed as 652.00. This has been corrected and the value will now display as 065.200.

WinRecs3\Abstracting\CCRS

PR_20826 Error When Using Apostrophe to Interface In

An exception error triggered when using an apostrophe for Interface In values. Sites can now use an apostrophe for Interface in values.

PR_20843 CCRS Chart Number Submission for OthersystemMRN

A change has been made for clients who have converted CCRS records into WinRecs from another system, where the Health Record Number format was different than how the number is stored in WinRecs. Now these values can be submitted without leading zeroes if they were previously submitted that way. This change is only applicable for clients receiving rejections for Health Record Number not matching who have recently transitioned to WinRecs for CCRS.

PR_20841 I10_Amcare views Is Abstract Validated Lite Not Displaying

The field called 'Is Abstract Validated Lite' in the I10_Amcare views was returning a Y1/E3 value. It will now return E, N, Y or W for IsValidateLite, IsCompleteLite.

PR_20849 Change CJRRJointIdentifier and Revision Reason

The CJRRJointIdentifier was returning the system value rather than the validate code. The following views have been updated to return the validate code:
