PR_22304 NACRS Invalid Generic Institution Numbers Not Generating Error

Level 3 NACRS was allowing invalid Generic numbers in Intuition to and from fields (example VZZZZ) which resulted in a rejection at CIHI. An edit will now generate in DAD, SDS and NACRS to exclude 99999 and *ZZZZ. NRS and OMHRS will also exclude the use of *ZZZZ Institution Numbers.

PR_22310 NACRS Incorrect hard edit on Diagnosis code S026

When Diagnosis Codes S02.6 and S02.21 were entered the following incorrect hard edit generated: **Multiple S026 Diagnoses**

PR_22313 NACRS Incorrect Anaesthetic Technique Edit

The following hard edit was incorrectly generating for multiple intervention occurrences where one occurrence has a value in the Anaesthetic Technique field: **Anaesthetic Technique Is Mandatory.**

PR_22325 NACRS Warning W2901 Not Generating

When Physician Initial Assessment date/time were prior to Registration date/time the following warning did not generate **Physician Initial Assessment prior to Registration suspect**

PR_22323 Incorrect Warning when Running DAD Deletion

When creating DAD/DAD Day Surgery deletion files the following incorrect warning generated: There are more than 999 maximum allowed records this batch. This will require a re-run, after this batch is complete, to collect the remaining records.

PR_22324 NACRS Lite Submissions Flag

An issue has been fixed for the NACRS lite submission flag. Previously when records were interfaced as level 1/3 and were saved in the level 0 module, they were not properly being flagged as NACRS lite upon save.

If you find some of your level 0 visits are returning when running a level 3 submission, contact support@med2020.ca for a patch to fix impacted visits.

PR_22327 NRS Submission File name Extra 0 in Sequence

When creating NRS submission files the file name was assigning an extra 0 to the sequence file name. Example, 001 instead of the correct format 01. This has been corrected.

PR 22328 NACRS 3 Correction File: Incorrect Submission Level in Control Header

Level 3 Correction Files had an incorrect submission code level of 2 in the Control Header. This has been corrected and the correct submission code level will be inserted.

PR_22329 NACRS L3 Correction Files Period Closure Control Header

For Submission Level Type D (level 1 and 3) and Submission Level Type E (level 2 and 3 submission), in the correction file the Period Closure Flag in the Control Header was set to 0 and should be 1.

PR_22314 NRS Weight Displaying Incorrectly

NRS weights were displaying incorrectly, Example: 52.5 displayed as 525.000. The format value will now display as 052.500.

PR_22315 NRS and OMHRS: Incorrect Attending Physician Hard Error

The following hard edit was displaying in some NRS and OMHRS assessments for valid providers: **The attending Physician has an invalid Value and must be corrected.** This error will no longer generate for valid Providers.

PR_22326 NRS Grouper Weight Displaying "0" on 2024 Assessments

NRS Grouper Weight Displaying as 0 on 2024 Assessments. This has been corrected.
