



Release Notes for WinRecs Version 302.1.0

Release Date: May 15, 2025

The 302.1.0 Fiscal Release includes 2025 CIHI Table Updates and Fixes Bug Issues.

This release is cumulative only after the most recent WinRecs Update has been applied however the update must be applied on minimal version **301.0.0** or greater.

Important:

After all releases have been applied sites with CACS and/or CMG groupers should have all coders check to ensure they can see grouper values in the visits. For Citrix clients this should be confirmed on all Citrix IP addresses. If grouper values are not displaying on a workstation/s please go to <ftp://ftp.med2020.ca/Winrecs2/Tools/> and download the file called regasm.zip. Extract the file to the desktop/s of the affected computer/s. Double click the file; a black window will flash, and the process is complete. This will register the grouper dll.

PR_25401 Newborn: Dx Code B95.6 and Dx Type 1 Edit Not Generating

When Admit category = N (newborn) and diagnosis code B95.6 with Diagnosis type 1 was used the following edits did not generate

10 04 05 If the admission category is newborn (N), diagnosis type cannot be 3

10 02 81 If the diagnosis is valid for use with type 3 on the diagnosis validation table (a value of 3 in the diagnosis type code column), the diagnosis type MUST be 3 or

PR_25402 DAD Edit 11 01 05 with Unknown Intervention Start/End Times

When Two Intervention Occurrences were entered with the same start date and both occurrences had start/end times as unknown the following edit did not generate:

11 01 05 If the Intervention Location Code is 01 or 08 and the first character of the status attribute is not A (abandoned) and the intervention code is not 'CANCELLED' and the OOH indicator is not Y, the same Intervention Episode Start Date with the same Intervention Episode Start Time must not be repeated on the same abstract

PR_25431 DAD Error 10 02 53 Not Working with Change of Entry Code

Initial entry for Entry code = N and Diagnosis code = Z380*. After save the Entry code was changed to D and an edit did not generate to prevent Z380* value being submitted which resulted in this error from CIHI:

10 02 53: The age, in years, must fall within the minimum and maximum ages of the appropriate diagnosis validation table for the diagnosis code. On the validation table a 000 minimum age indicates no lower limit. a 130 maximum age indicates no upper limit and a 000 maximum age indicates entry code must be newborn (N) or stillbirth (S)

Entry code must = N to use Z380*, Z383*, Z386*

This issue has been resolved.

The Room Unit field value will now copy from the L-0A into the L-01 when the user creates the L-01 from WinRecs.

WinRecs2\Administration\Hospital Profile

PR_25409 Create New Field in Hospital Profile disable edit in CCM for NACRS

A new field has been added in the Hospital Profile called: CCM In NACRS Submission. When CCM In NACRS Submission field is set to N, the CCM edits will not display in the NACRS visit and the fields will not be included in the submission.
