For clients with the CACS and CMG+/ CACS groupers please ensure all users are able to see the grouper information within the abstracting modules after applying this update. For clients with CACS and CMG+/CACS groupers you must batch group data prior to submitting Period 01 for 2016.

AmCare (NACRS)

0370 Arrival Date/time Disabling with CL and DS cases

The Arrival Date and Arrival time fields for CL and DS Ambulatory Care Groups were inadvertently disabled on a previous release. The fields have been changed back to enabled and data capture of these two fields is for internal use only and will not be submitted to CIHI.

Chart Maintenance - CPI (Central Patient Index)

0244 Merge Mom and Baby in CPI

In the CPI, when a mom or baby chart were merged the Maternal/Newborn Record did not populate in the corresponding chart fields and the user had to go in and manually enter the chart number in the required fields. This enhancement will now:

For baby's CPI the mom chart number will populate in the Mother's Chart Field.

For mom's CPI the baby's number will display in the Baby Chart Multiform.

Crystal Views

0406 I10_Amcare_And_MIS_VR, incorrect name

In I10_Amcare_And_MIS_VR, there are two fields called Exp1 and Exp2. The Exp1 returns the MIS code from the MIS Code multiform and Exp2 returns the description from the MIS code multiform. Both these fields have been renamed to MIS Code and MIS Code Description.

0462 MDS20_Admission_VR

An issue with the MDS20_Admission_VR in which DailyEventBusy_AC1d and DailyEventBusyDesc_AC1d showed reverse values.

The values will now display correctly for these two elements when using the the MDS20_Admission_VR.

Mental Health (OHMRS)

0464 OMHRS - DSM-5 Tables

The DSM-5 tables have been integrated into the OMHRS module.

RUG

0362 RUG 44 Values in Winrecs differs from CIHI

For some Assessments there was a discrepancy with the RUG values in Winrecs compared to CIHI. The CMI values specifically the Rehabilitation cases have been corrected and now match CIHI.

0461 CCRS: RUG Batch Grouper Issue

A Batch Grouper Issue was found with the RUG Grouper in which element B2a was set to a wrong value in the grouper. When the assessment was saved the correct value was assigned. The grouper now returns the correct value.

System Maintenance - Institution Profile

0419 Institution Profile - CCRS Not Pad Zero Chart Number Field

The following field has been added to the CCRS Institution profile: "CCRS Not Pad Zero Chart Number".

This field is for new CCRS clients only and the field value is controlled by MED2020 and is permanently disabled.

System Maintenance - Look Up Profile

0384 Institution Incorrectly Invalidated

Some Sites reported that Institution Number 51079 was invalidated with an incorrect user description of Zz96/10 Metropolitan Gen Hosp.

The description has been set back to Windsor Regional Hospital-Metropolitan - Windsor (AT) and the valid to date set to 20990331 in the Institution (ICD 10) tables.

System Maintenance - Provider Maintenance

0386 Provider Unavailability Type Options

In Provider Maintenance/Provider Unavailability multiform, there was only one Provider Unavailability Type. There was no option to add more. This enhancement now has a look up called "Deficiency Unavailability Type" in the Look up Field Maintenance where the user can now add more unavailability types.
