When the following hard error generates: "If dischargedisposition is transfer (10,20,30 or 40) then Institution To cannot be blank. The "Institution To" Field Indicator will now flag as a mandatory field.

PR_27195 Error Message 10 00 67 Generating Incorrect Hard Edit

When the same following J dx codes were entered more than once with the same dx type the following edit was generating incorrectly:

Error Message 10 00 67: The diagnosis codes J440, J441, J448 and/or J449 cannot be coded on the same abstract as diagnosis type M, 1, 2, 3, W, X or Y

PR_27247 Patient/Transfer Service Data not populating warning if overlapping dates

A warning message will now populate if there are overlapping Transfer In and Transfer Out dates in the Patient/Transfer Service Datamultiform.

PR_27312 DAD CJRR: Incorrect Hard Edit Generating

For DAD CJRR the following incorrect hard edit was generating when more than one occurrence of component was entered:

If (Intervention Code is 1VG53^^ AND not 1VG53LASL^) AND (Status Attribute is P) AND (Extent Attribute is 1A, 1B, 1C or 2A, 2B, 2C, 2D) AND OOH Indicator is blank AND Intervention Joint Identifier is the same as Joint Identifier then there must be at least two coded occurrences of Component, one occurrence of Component = 3 AND/OR one occurrence of Component =4 AND/OR one occurrence of Component = 5

This has been corrected so that the edit only triggers when only one component occurrent is entered when the above values are entered.

PR_27184 CCRS/OMHRS Submission Files: Deletions Not Flagged with D

The Submission Type for CCRS/OMHRS deletions was showing as N, instead of D in the submission file. This has been corrected and will now populate as D.

A change has been made so that records cloned by the auto batch clone service, will be assigned a coder number of the Batch Clone.

PR_27258 Error 45a46 - 45j46 Not Generating for NACRS Level 3

When dxcodes I21 or I22 were entered at third digit level or I 24.0 as Other Problemno hard edit was generating if one of the following R94.3*dx codes were not also entered as other problem: R94.30, R94.31, R94.38.

A hard edit will now generate if R94.3* is not also recorded as Other Problem with the above "I" codes.

PR_27264 Incorrect Edit triggering for NACRS Day Surgery: Element 52 Main Intervention Location

For Care type B-D (day Surgery) when all intervention fields are blank an incorrect hard edit was generating as follows:

Main Intervention Location is mandatory for DS

This edit will now only trigger if main intervention code is entered as per this edit:

If Ambulatory Care Group is = DS*, and if Reporting Province/Territory = NL, NS, NB, ON, and if Main Intervention is coded and is not 'CANCELLED', then the Main Intervention Location Code must not be blank

PR_27246 Activities and Participation values missing details in Look Up Notes

NRS Activities and Participation table values contains detailed information stored in Look Up Notes column.

WinRecs3\Modules\Clinical\[MHRs] Mental Health Registry System

PR_27259 D1a Self Injury Attempts when 0 D1b does not default 8 and disable

D1a Self-Injury-Attempts enter 0-Never it will default in D1b Self-Injury-Intent 8-No Attempt and this field will disable.

PR_27290 Institution Profile Lock Down Date not looking at Assessment Reference Date

For Mental Health, the Lock Down Date in the Institution Profile will look at the Assessment Reference Date of the Assessment.

PR_27291 NACRS Submission Level Code defaults to 3 not NULL

When an ER visit is interfaced only and not submitted for Level 1, the Submission Level Code will default to NULL. When a Level 1 file is created the Submission Level Code will be 3.

PR_27307 Project 440 View Question 9 Values

An issue has been corrected where the Time of Qualifying Scan second digit (question 9) was incorrectly returning the value from question 8. The view will now properly display the question 9 value.
