PR-2779 CCM: Incorrect Hard Errors Health Care Professionals

When no information was entered in the Health Care Professional Multiform hard errors would incorrectly generate. These hard errors have been removed as Health Care Professional fields are optional.

PR-2792 CCM Topography Codes for Lymphoma

Previously for some lymphoma diagnosis codes, the applicable topography codes available were not filtering correctly and omitting some codes. The topography code filtering has been fixed.

ED-2770 Central_Pateint_Index_Vr: Region Code

Region Code and Regional Code descriptions were pointing to the Regional Profile. These fields will now point to the Residence Code Region.

ED-2787 Update Views for Residence Province

The ResidenceProvince and ResidenceProvinceDesc fields have been fixed to return values based on the residence code used in a record.

ED-2780 MDS20_General_VR Missing Descriptions

The MDS20_General_VR was missing some descriptions. The descriptions have been updated in the view.

PR-2797 HIG Optimized Values Not Displaying in HIG Optimizer

In the Grouper Optimize Window the HIG optimized values were not displaying. This has been corrected and now both CMG and HIG optimized values will display.

PR-2798 HIG Radio Button Default Does Not Retain

When HIG Radio button was selected this default did not retain after logging out of WinRecs. This default will now retain and the HIG values will be the primary display if chosen as default,

ED-2784 Group/Field Numbers/Descriptions Added to DAD CJRR Form

The Group and Field numbers as well as Descriptions have been added to the fields in the DAD CJRR form.

PR-2791 CJRR Edit Error Number 20 07 05 Not Generating

DAD CJRR Edit 20 07 05 was not generating for the following scenario:

Interv Code: 1VA53LAPMN

Att Status - P

Att Location - L

Att Extent - M2

Interv Location - 01

Component 1- Hip-Femoral

Component 2 - Hip- Acetabular

The following edit will now generate when a second component is entered:

If (Intervention Code is 1VA53LAPM^ OR 1VA53LLPM^) AND (Status Attribute is P) AND (Extent Attribute is M1, M2 or UN) AND OOH Indicator is blank AND Intervention Joint Identifier is the same as Joint Identifier then there must be one and only one occurrence of Component = 1

Mental Health - OMHRS

PR-2760 OMHRS Missing Option to Change Assessment Type

A “change assessment type” feature has been added to change an admission assessment to a short stay assessment. This feature can be accessed by Actions located above the Module Banner Name.

PR-2785 Responsibility for Payment X50a-X50i Incorrect Hard Error

Responsibility for Payment Hard Error was generating on both the Quarterly and Discharge Assessments. The hard error has been removed as Responsibility for Payment is only mandatory on the Full and Short Stay assessments.

PR-2786 Capacity/Competency fields A4a-A4d Mandatory on Discharge

When Capacity/Competency fields (A4a-A4d) were not completed in a discharge assessment no hard error generated. These fields will now flag as mandatory in the discharge assessment.

ED-2763 NRS: Update Description for Living Arrangement Field

Element 12-f Living Arrangement Description has been updated as follows:

PR-0003 Service Interruption Values Not Transferring to Discharge Assessment

The Admission Service Interruption Values did not carry over to the Discharge Service Interruption when there was also an Interim Assessment. This issue has been resolved and Service Interruption values will not carry over to the Discharge assessment.

EN-0006 Unable to Open RUGS Box

Double clicking on RUGS box in the CCRS assessment will now display the fields and values.

System Maintenance – Control File

EN-2492 Control File: Resequence Visit History Windowpane

Users can now sequence the order in which the Visit History columns display.

System Maintenance – Look Up Profile

ED-2739 Adding Values to Institution Table Type Default

When adding a new entry to the Institution table in Lookup maintenance, if the CIHI code already exists for the new entry, then the default will apply the institution type value that matches the CIHI code value already in the table.

ED-2765 Fiscal 2021 DAD Institutions and Types V1.1

Fiscal 2021 Dad Institutions and Types V1.1 have been added to this release.

ED-2774 MB: Change MH Facility Description

The description for MH facility number 0621 has changed from Eastview Lodge to Country Meadows PCH.

ED-2796 CED-DxS-v7.2 Updated Table

The CED-DxS Table has been updated with version 7.2.

System Maintenance – Provider Maintenance

ED-2778 Remove Option To Delete Provider Service

The ability to delete a provider service that is linked to provider has been removed. This is to protect against deleting a service which clears the value in all records that service was used to code in. Instead of deleting services it is recommended to inactivate them using the valid to date instead.

System Maintenance – Regional/Hospital Profile

ED-2756 Remove Option to Show Diagnosis in Visit History Tool Window

The “Show Diagnosis in Visit History Tool Window” option has been removed from the Hospital/Regional Profiles. The option will remain as a field selection in the visit history control file.

Utilities – CIHI Submissions

PR-2762 Clinical Module Submissions: Missing Batch Period

In File Management the Batch Period field only displayed Quarters for NRS, OMHRS and MDS. The option to select Batch Periods has also been added.

PR-2799 Opioid Submissions - Header Count Issue

When running a NACRS submission file for Care Type B-E-O ED Opioid Cases, the “Query Opioid “ visits were included in the submission file but were not being counted in the submission header within the file resulting in the count not matching. This issue has been resolved and the count will now include the Query Opioid cases.

Utilities – CIHI Corrections

ED-2654 DAD Correction/Deletion File Verify Count

When a CIHI correction file is created there is now an additional pop up that will list how many corrections and how many deletions are included in the file.

PR-2759 No Record Lock When Creating Corrections File

An issue has been resolved that was preventing records from being locked out of when a correction is being run for that set of records. When a record is locked out it cannot be opened by a coder.
