WR3-36 Standardized Data Format

When the date format in User Profile is set all corresponding date fields will now reflect this format. These fields include all Look Up Fields, Multiforms, Abstract Queue, Visit History, Record Update History and Interface Update History. This change does not apply to fields that are a date/time format.

Cancer Care (CCM)

WR3-21 First Definitive Cancer Surgery Treatment or Biopsy Flag

On registrations prior to 2021 the First Definitive Cancer Surgery Treatment or Biopsy Flag was field generating a hard edit to make this field mandatory. The mandatory edit for this field will no longer generate on older registrations.

WR3-27 Change Column Sequence Cancer Care Registration Pane

The Cancer Care Registration Pane in the NACRS Module will now have the following sequence order: Sequence Number, Registration Date, Problem, Chart Number, Institution Number, Hospital Link, Registration Link

WR3-69 Staging Fields Not Enabling

For new Disease Registrations the Staging fields did not enable for 2020 registrations. This issue has been resolved.

CIHI Submissions

WR3-34 Deletion File Verify Record Count

When creating CIHI deletion files, the count displayed for deleted records in the file will now properly display the number of records included. Previously the number returned 0 because records being deleted were not verified.

Crystal Views

WR3-67 [MDS20_Quality_Indicators_ByYear_VR] Not Returning Results

An issue has been resolved with this view that was preventing the results from returning.

DAD Inpatients

WR3-25 CJRR – Incorrect Hard Error Uncemented Hip and Knees

When entering an uncemented Hip or Knee code a hard error was being generated to populate the cement information. This has now been fixed.

WR3-68 Increase Length of Intervention Field “ORURN”

In the intervention multiform for DAD records. The field length for the field 'ORURN' has increased from 10 characters from 2.

Rehabilitation (NRS)

WR3-13 2021 RPG Grouper Weights Display as 0

For Assessments with Discharge Dates after 2021/03/31 the RPG weights were displaying as 0. This issue has been resolved.
