[PR_15559](#) **Error Not Generating for Diagnosis Codes P700, P701 and P704**

A hard error was not triggering when diagnosis P700, P701 and/or P704 was coded on the same abstract. The hard error will now trigger when these diagnosis codes are coded on the same abstract. The error reads "***The diagnosis codes P700, P701 and/or P704 cannot be coded on the same abstract as any diagnosis type.***"

PR_15647 Height enter as 182 it displays as 18.2

In the Height field when enter 182 it displayed the Height as 18.2 rather than 182.0. This has been resolved and the correct format will display.

PR_15575 User Defined views Numeric fields return value 0

Any Crystal view containing User Numeric fields was returning a value of 0 instead of the value in the abstract. The views have been fixed.

WinRecs3\CPI

PR_15595 Death Indicator and Date Patient Died

When Death disposition code entered in the Inpatient (72,73,74) and Amcare (71,72,73,74) it populates the CPI with Date Patient Died and Death Indicator Y. If Disposition Codes are change to non-death codes, it will remove the Date Patient Died and Death Indicator Y in the CPI.

PR_15603 Auto Coder Service

A new feature is available in WinRecs to schedule records to be cloned in bulk using the same method as a manual WinRecs clone. For the configured MIS codes, all unsaved records will be cloned if the patient has a previous visit with the same MIS code. To add this feature contact sales@med2020.ca

PR_15604 Assigning Incorrect Submission Batch Number

If a submission file with was created for the same period after a zero submission had been submitted the second file was assigning batch number 01 for the first batch in this file instead of the correct batch assignment of 02. This issue has been resolved.

WinRecs3\Abstracting\NACRS

PR_15626 Amcare Intervention Start or End Time Unknown 99:99 to default Duration as 9999

In the Amcare Care Intervention Multiform, when Intervention Start or End Time is initially entered as Unknown 99:99 it will default the Duration of Intervention to 9999. If the Intervention Start Time or End Time is changed to Unknown, the Duration of Intervention will change to 9999 when the times are Unknown.

PR_15633 Crystal Stored Procedure Error When Resetting Datasource Location

Stored Procedure called 'R_BatchVerifyErrorsWarnings;1' had been fixed, This Stored Procedure is used to generate the Chart Numbers with Errors and Warnings generated when performing a Batch Verify in File Management. The WR3 canned report using this Stored Procedure can be found on our FTP site. The report is called fm_print_batch_verify.rpt

PR_15641 Autocode Abstract Profile - Remove Prompt

When copying an Abstract Profile the prompt 'Abstract Profile successful' has been removed.

WinRecs3\Utilities\CIHI Submission

PR_15642 Submissions For Specified Care Types

For NACRS in File Management you are now able to verify and create submissions/correction files while users are accessing other care type visits for the same Batch Period.

PR_15661 NRS Submission: Hard Error Invalid Provider Type

For NRS, some clients received hard errors from CIHI on Provider Type. The Stored Procedure used in NRS submission is now pointing to the correct table called LU Provider Services.

PR_15689 Allow Abstracting While Running Different Care Type Submission

Submissions were not processing for NACRS when any abstracts for the specified period were being accessed. This has been changed so that submissions will run for a specified care type while other care types for the same period are being accessed.

Example: A Emergency submission for April can be running while coders are accessing Day Surgery abstracts for the same period.

PR_15646 Visit History - Sort Order

The sort order in visit history has been changed as follows: Visit Date descending, Admit Date descending, Admit Time descending, Discharge Date descending, Hospital ID

PR_15660 Edit Generating Incorrectly for U073 and U074

When Diagnosis code U073 was entered as the main with Dx Prefix 7 and U074 was entered as the second occurrence the following hard edit was generating:

If Diagnosis Code U074 is recorded, then there must be at least one other Diagnosis Code from A00-T98 or U073 with the Diagnosis Prefix 7.

This edit will no longer generate for the above scenario.

WinRecs3\Administration\Hospital Profile

PR_15649 Reason For Deletion Prompt

In Region and Hospital Profile, the 'Show Delete Reason' prompt now has options.

Y - Yes, Delete Reason is required

O - Yes, Delete Reason is optional

N - No, Delete Reason is not required

WinRecs3\Abstracting\MHRS

PR_15656 Invalid error on Discharge for Total Days Away from Bed=0

If the Admission Assessment is in the previous Fiscal Year and Discharge Assessment in current year when 'Total Days Away from Bed = 0, the following hard error generated on the discharge assessment:

Invalid X131 Days Away from Bed in Previous Fiscal Year. X131 Days Away from Bed in Previous Fiscal Year cannot be blank if X130 >0 and A1 Assessment Reference Date of the patient's last assessment and X80 Discharge Date occur in different fiscal year.

This issue has been resolved.
