This release is cumulative only after the most recent WinRecs Update has been applied however the update must be applied on minimal version **2021.01** or greater.

**Important:**

This release includes the ability to capture NACRS CJRR and will be submitted with separate submission file as per CIHI Guidelines. Please reference the WinRecs User Guide as well as CIHI guidelines for submitting NACRS CJRR.

ED Department Intervention Pick List and Investigative Technology fields have been retired for 2022 and replaced with ED Intervention Value Set.

On WinRecs 2022.01 the following two codes cannot be used as Main Diagnosis for DAD/NACRS:

- 1) U07.4 Post COVID-19condition
- 2) U07.6 Need for immunization against COVID-19

WinRecs Version 2022.01 contains a Fiscal Grouper Engine update. Clients with the CACS and CMG+/ CACS groupers please ensure all users can see the grouper information within the abstracting modules after applying this update. For clients with CACS and CMG+/CACS groupers you must batch group data prior to submitting Period 01 for Fiscal Year 2022.

After all Fiscal Releases and Service updates have been applied, coders should check to ensure they can see grouper values in the visits. For Citrix clients this should be confirmed on all Citrix IP addresses.

##### **PR\_20316 Emergency Department Intervention Value Set**

The ED Intervention Picklist (3 character CCI Codes) and Information Technology multiforms have been retired for 2022. There is a new multiform called ED Intervention Value Set with a picklist that includes full CCI codes which have been assigned Intervention Types of either Investigative Technology or Therapeutic. Investigative

Technology CCI codes will enable the Number of ED Investigative Technologies Performed field. You can now submit 6 occurrences each for both Therapeutic intervention and ED investigative technology.

## PR\_20320 NACRS CJRR and Reporting

For Fiscal 2022 sites can now submit NACRS CJRR. To collect and submit NACRS CJRR you must first go to the Institution Profile and add a Y to the **Use CJRR Worksheet** field. The intervention codes allowed for CJRR will enable the NACRS CJRR form which can be accessed by clicking forward (F12) in the intervention multiform.

**Important:**

- 1) Revision Reason (element CJ01) is in the intervention multiform. If the field is not visible please enable in the control file.
- 2) NACRS CJRR is submitted in a separate submission file as per CIHI guidelines. When a Level submission is run and there are visits with NACRS CJRR two files will be created - a level 3 submission file as well as the NACRS CJRR Submission file. The level 3 file (lower sequence number) must be submitted and accepted by CIHI prior to submitting the NACRS CJRR Submission file (higher sequence).
- 3) Only One NACRS intervention can be submitted per visit.

The report will now auto execute upon saving in a visit.
