When a workstation has a computer date format on their computer of D/M/YY. WinRecs was previously interpreting this date converting 2099 to instead be 1999 for the valid to /from columns in lookup fields. These dates will now display properly.

On computer when the Regional settings of computer is set to display 2 digit year 1/11/22, in Provider Maintenance, Provider Service section the Valid To date is displayed as 1999/03/31. Regardless of how the Regional Setting is set to 4 or 2 digit year, the Valid To date will display year as 2099.

PR_20471 Batch Grouper missing 'Store Optimize Data' option

In WinRecs 3, Tools, Batch Grouper 'Store Optimize Data' is now visible. This gives the user the option to 'Store Optimize Data' when box is checked.

WinRecs3\Utilities\CIHI Submission

PR_20588 ER visits are flagged as Level 0 submitted

ER visits were being flagged as submitted for Level 0 and user was unable to make changes to the visit for Level 3. This is a result of a new submission flag added and has been fixed in this update.

PR_20704 Disposition Code 61 not Clearing Provider Number

For level 1 submissions when Disposition code is changed to 61 the Provider Number was not removed and was included in Level 1 submission file resulting in a rejection. For this scenario the Provider number will now be removed when Disposition Code is changed to 61.

PR_20620 CJRR Module File Create Error

Clients were getting Unhandled Exception Error when creating CJRR submission files for visits created in the CJRR module. This issue has been resolved.

WinRecs3\Abstracting\MHRS

PR_20648 Incomplete Interfaced Assessments Show Is Validated Y

For clinical modules NRS, OMHRS and CCRS interfaced assessments when doing F4 search "Is Validated" showed as Y and visit history color indicator box displayed as green (complete) even though the assessment was incomplete with errors. This issue has been resolved.

PR_20658 OMHRS: Revised Edit for Element X160 Schizophrenia

Collection rules for X160 Schizophrenia have changed as follows:
Short Stay Assessment Type 7 – X160 is always mandatory

Discharge assessment Type 5 - X160 always Mandatory if LOS is <= 6 (Short Discharge not Short Stay Assessment) days then Reason for Discharge does not matter and X160 should not be blank and

if LOS >6 and X90 Reason for Discharge not =1 then X160 should not be blank.

For the cases where Reason for Discharge = 1 and LOS > 6 if Q2a is has one of the F25* or F209 schizophrenia codes then that replaces having to code X160 = 1 and if no Q2a code of F25* or F209 was entered then that implies no for schizophrenia. So for all cases where LOS > 6 days and Reason for discharge = 1 element X160 is not mandatory.

WinRecs was allowing Element A3 Case Record Number to enter and submit a Case Record Number containing a slash (/) which was rejected by CIHI. An edit will now generate when a slash is entered as part of the Case Record Number.

Generic Institution To and From Numbers 69591 (law enforcement) and 69395 (virtual care) can now be used in combination with discharge disposition code 04 and MB Facility Number 9999.

PR_20693 BC Clients: Modify DAD Edit 07 01 08 for Patient Service 76

For the below BC edit Institution Number 90105 has been added to the specified list of Institution numbers valid to use with Patient Service 76:

Edit 07 01 08: If the first character of the institution number is British Columbia (9) and the institution number is not on the specified list of institution numbers valid to use patient service 76, the main patient service must not be 76

This release includes MB Health Updated ALC Z Code and ALC Reason Codes

Validation. There was also an issue when ALC Reason code 49 was used with any of ALC Z** Diagnosis codes the following incorrect hard edit generated:
Invalid ALC Reason Code for the Diagnosis code.

This issue has been resolved and ALC Reason Code 49 can now be used with any ALC Z** Diagnosis Code.

When Relocating Visits in Chart Management an exception error was generating for any visits that were submitted. This issue has been resolved.

PR_20664 NACRS L2 Discharge Diagnosis Code Invalidated

The following ED discharge diagnosis codes were assigned the wrong valid to dates and couldn't be used in 2021 visits. The correct valid to date has been added (20220331) and they can now be used in 2021 Level 2 visits:

F199, F159, F129, K20, R17, T407

PR_20707 NACRS Reproductive Fields Enabled

NACRS Elements 69 to 74 are now enabled and optional for Levels 1, 2, 3 DS, CL and CL Lite with the exception when Main Problem O04^ and intervention code of 5CA88^^ or 5CA89^^ are used then Elements 69 to 74 are mandatory.

WinRecs3\Abstracting\CCRS

PR_20671 Universal Episode Identifier Disabled

The Universal Episode Identifier in Admission Background is now enabled by default to allow for entering and editing. When entering or editing Universal Episode Identifier on the Admission Background it will auto default into the other assessment types or update the Universal Episode Identifier on the other assessment types.

PR_20736 CCRS Weight Edit C1189 Not Triggering

When a value of 9 was entered in Element K3a Weight loss or K3b Weight gain for Annual Full Assessments or Significant Change to Full Assessment the following edit did not generate:

For annual full assessments or significant change to a full assessment (AA8 = 2 or 3),resident must be assessed for weight loss (K3a = 0 or 1).

The edit will now generate when a value of 9 is entered for Weight loss/gain in the above assessment types.

PR_20737 CCRS Edit Number C1188 Perception of Daily Life Not Generating

When a value of 9 was entered in Element F3c Perception of daily life on Annual Full Assessment or Significant Change to Full Assessment the following hard edit was not generating:

For annual full assessments or significant change to a full assessment (AA8 = 2 or 3),resident must be assessed for perception of daily life compared to prior pattern in the community (F3c = 0 or 1). Does not apply to comatose residents (B1 = 1).

The edit will now generate when 9 is entered in Element F3c for Annual Full Assessment or Significant Change to Full Assessment

PR_20673 I10_Amcare views not showing Clinic Lite visits MIS code 7145*

When run a report using the I10_Amcare_VR or any I10_Amcare views, it will display Clinic Lite visits.

PR_20687 AbstractQueue_VR returns Coder/Description Blank Values

When running a report using the AbstractQueue_VR, the coder and coder description no longer returns blank. The visits displays the coder that the visits are assigned to.

In NRS Discharge Assessment, Element 31 Reason for Discharge is now flagged as CIHI Mandatory.

PR_20740 NRS: Incorrect Edit for Transfer/Death Health Condition Admission Assessments With Admission Class 4

On an Admission assessment when Admission Class = 4 the following incorrect hard edit generated:

If patient transferred from Rehabilitation or Died, should have an admission transfer or death health condition with admission class 4.
