When crystal report has a parameter field created called {?UserID} and in the Report Selection {?UserID}={UserProfile_VR.CoderUsername} and report is run in WinRecs, this parameter will automatically return the username from User Profile.

PR_21404 Duplicate CJRR Entries in NACRS CJRR Submission File

When a user is submitting a NACRS CJRR and a record has an intervention code with the same rubric such as 1.VG.53, Winrecks was creating 2 CJRR visits in the submission file when it should have only been creating one. This issue has been fixed and only one visit is created in the submission file.

PR_21407 NACRS Abstract Number Field Length

The field length in the record search window for Abstract Identification Number on NACRS(Level 0, 1 and 3) has increased to 7.

WinRecs3\Utilities\EMT

PR_21405 EMT Field Condition value list column always highlighted

In the Field Condition editor when select the values in the value list, the column names and value in the list remained highlighted. When click to un-highlight or click to highlight another area, the highlight was not removed. This issue has been resolved.

PR_21455 EMT Same Multiple Occurrence Group is not displayed in Editor

When create the edit message and LINK a Logical Condition, the preview will display if 'Same Multiple Occurrence Group' was used in the Logical Condition.

PR_21456 EMT Message does not clear when Logical Condition contains Field and Logical Condition

If a Logical Condition involves another Logical Condition and a Field Condition and 'Same Occurrence Group' is selected, the edit will now clear if the abstract is corrected.

PR_21520 EMT Between Operator unable to enter values

When create Field Condition and select Operator 'Between' can enter values in the 'Between From' and 'Between To' fields.

PR_21532 EMT-Edit and Hospital Linked Users

If a user is assigned a Profile Link and the edit is assigned the same Profile Link, in the abstract the user will only see edits that apply to the user's Profile Link. This applies to the Inpatient, Same Day Surgery and Amcare module.

The fields Chart Number, Case Record Number, Date Stay Began have been added to OMHRS_InHospital_VR

WinRecs3\Abstracting

PR_21416 Intervention Attribute Disappearing DAD/NACRS

Intervention attributes were disappearing for the first occurrence intervention upon entering a second occurrence. This issue has been resolved and entering more than one occurrence in the intervention data multiform does not cause previous intervention attributes to disappear on DAD and NACRS.

PR_21426 Link Not Working for Warning Message for Maximum occurrences for Provider

When the warning message displays for Maximum occurrences for provider, when clicking the the warning message it does not go to the Provider multiform. This issue was occurring for all multiforms. This has now been fixed for all multiforms.

PR_21445 NACRS HCN = 1 is Valid when Responsivity for Payment = 03

An adjustment to the edits to always allow a Health Care Number value of 1 where the responsibility for payment is 03 regardless of what the HCN province is.

PR_21499 Nunavut - Postal Code and Residential Code

The postal codes for Nunavut were displaying the wrong default residence code. This has since been fixed and now defaults to the Nunavut residence codes.

WinRecs3\Utilities\Abstract Queue**PR_21432 Getting exception error in Abstract Queue**

In the Abstract Queue stabilized the tool to reduced or eliminating exception errors when navigating.

WinRecs3\Abstracting\CCM**PR_21434 Cancer Care - Add New Codes to AJCC Staging Version 9**

Staging Version 09 has been updated to allow codes for Appendix, Anus and CNS - these new codes are effective as of January 1, 2023.

WinRecs3\Administration\Control File**PR_21436 Coder Number defaults when not set in Control File**

The coder number will automatically default into the coder number field when the Coder Number default is set to 00 in Control File. If the Coder Number default is blank, no default value will apply.

WinRecs3\Reporting\Report Maintenance**PR_21444 Exception Error in Report Manger**

When selecting and cancelling reports in the Report Manager an exception error was generating. This issue has been resolved.

WinRecs3\Abstracting\DAD**PR_21523 Add 'Discharge Planning' Field to DAD**

Discharge Planning (an existing DAD field in WinRecs 2) has been added to DAD.

PR_21534 Issue with Prov Issuing HCN and HCN for Stillbirths

When Entry Code = S, HCN = 9 and HCN Province = MB the following incorrect hard edit was generating:

HCN is invalid according to Province

This incorrect edit has been removed for Stillbirths for all provinces.

PR_21537 Day Surgery module-Enter Intervention Date/time does not populate Intervention Episode Number

In Day Surgery, Intervention Episode Number will populate when Intervention Occurrences are entered.
