I10_AllAbstractingGeneral1_VR: The IsAbstractValidated field was returning incorrect values for Amcare visits.

The I10_AllAbstractingGeneral1_VR will now return the following values:

Y, E, W or N for IsAbstractValidated, IsCompleted

Y, N for IsSubmitted

I10_AllAbstractingGeneral1_VR was returning MIS code that were not Emergency MIS Codes. The view has been modified to return only those cases where Amcare Group = E.

PR_22245 Error #45b30 Not Generating With Multiple J44* COPD Diagnosis Codes

When Multiple J44* COPD Diagnosis Codes were entered the following error was not generating in Amcare: Error #45b30 Multiple J44 COPD Diagnoses. The error will now generate.

PR_22247 Error #5301 Anaesthetic Technique Not Generating

Error #5301 Anaesthetic Technique will now generate when Anaesthetic Technique is blank.

PR_22289 Error Diagnosis A00-T98, U07.3 Diagnosis Prefix 7 Not Clearing

The following edit was generating incorrectly when Main Diagnosis or Other Diagnosis had Diagnosis Type 7 and Other Diagnosis code U07.4

Main/Other Problem A00-T98 or U07.3 with Main/Other problem Prefix 7 is mandatory.

This error will no longer generate for this scenario.
